#### **CURRENT COMMISSIONER STATUS**

- Neil Chatterjee (R), Chairman
  - Term expires June 30, 2021
- Rich Glick (D), Commissioner
  - Term expires June 30, 2022
  - Recusal issues through November 29
- Bernard McNamee (R), Commissioner
  - Term expires June 30, 2020
  - · Recusal issues expired
- Sept. 30: President Trump nominated James Danly (R) to FERC for the remainder of a fiveyear term expiring June 30, 2023
  - Currently, FERC General Counsel
  - Former attorney in the energy regulation and litigation group at Skadden Arps Slate Meagher & Flom LLP law firm
  - Senate Energy Committee hearing held November 5
  - Confirmation expected, perhaps along partisan lines, in the next few weeks



#### **GENERATION ISSUES**

- ■PJM Capacity Reform
  - State vs. FERC jurisdictional issues in play
  - Delayed PJM capacity auctions from May 2019 to mid-2020 or later
- Order 841 (Electric Storage) Implementation
  - Wholesale market participation
  - State vs. FERC jurisdictional issues in play (appeal pending)



# GENERATION ISSUES (cont.)

- Carbon Pricing in FERC-Jurisdictional Markets
  - Carbon costs currently allowed in energy offers
  - Key issues percolating over emissions/economic "leakage" issues
- Energy Price Formation
  - FERC goal: Energy prices should reflect all necessary attributes of system operation (reserves, fast-start capability)



# GENERATION (cont.)

- Resilience
  - Still pending in FERC-created docket
  - Little "noise" about further FERC response to DOE concerns
- PURPA NOPR (to be discussed later in meeting)



#### TRANSMISSION ISSUES

- Pending Complaint Cases on Return on Equity (ROE)
  - New England, MISO, etc.
- Notice of Inquiry on ROE
- Notice of Inquiry on Transmission Rate Incentives
- Transmission Facility Ratings Technical Conference/Comments



# TRANSMISSION ISSUES (cont.)

- Asset Management"
  - How much control should transmission owners have?
- Cost Allocation
  - Adherence to cost-causation/cost-benefit principles
- Order 1000 Affirmation
  - Leveraging competition to contain transmission costs
